### Health Guarantee and Seller Commitments

1. Health Certification: The seller certifies that the puppy is in good health at the time of sale, as confirmed by a veterinarian examination and visual inspection. The puppy has been determined to be of good weight, free from physical defects (unless otherwise noted and agreed upon for a discounted rehoming fee), and shows no signs of ill health. At minimum, the puppy has received its first set of vaccinations and deworming.

2. Health Guarantee: Bella's Beautiez offers a 1-year guarantee against life-threatening congenital defects. Should a defect be identified within this period, the buyer must submit veterinary documentation for consideration of a replacement puppy. This guarantee excludes minor, treatable conditions or any conditions caused by stress, accidents, or preventable issues. The guarantee becomes void if vaccination records are not maintained and provided.

3. Relocation Requirement: If the buyer relocates to a location where the breed or dogs are not allowed, they are required to return the dog to the seller.

4. Regular Updates: The buyer agrees to keep the seller updated on the puppy's health,

living environment, and to share photos periodically. Bella's Beautiez values staying in touch with each puppy's new family.

5. No Guarantee of Perfection: While Bella's Beautiez carefully breeds for temperament, conformation, and health, no guarantees are made regarding future size, temperament, or appearance. Ongoing support is offered, and the seller is available for guidance or advice.

6. Documentation Transportation: The seller agrees to send all relevant documentation, including vet records, via mail to the buyer.

### Buyer's Responsibilities and Acknowledgements

By signing, the buyer acknowledges that they have no legal restrictions on owning the breed and agrees to the terms outlined in this contract.

1. Responsible Ownership: The buyer commits to providing a safe, loving, and healthy environment for the puppy, maintaining vaccinations, flea/heartworm prevention, and proper diet.

2. Microchipping and Registration: The puppy will be microchipped under Bella's Beautiez's information as a safeguard. Should the buyer become unreachable, Bella's Beautiez reserves the right to reclaim the puppy.

3. Rehoming and Breeding Conditions: The buyer must notify Bella's Beautiez if they can no longer keep the puppy, and written consent from the seller is required before any rehoming occurs. Unauthorized breeding or failure to meet these terms may result in a fine or forfeiture of ownership.

### Breach of Contract and Penalties

Any breach of this contract will result in the forfeiture of ownership and a \$25,000 fine. The seller reserves the right to pursue legal action if this fine is not paid. All deposits and payments made by the buyer are non-refundable.
